# Transaction Analysis

## Activity

- During 2024, there were a total of 105 M&A deals reported in Argentina.
- The number of transactions was 22% higher than that of 2023 (86 operations recorded).


## Buyers' Profile

- The majority of transactions closed corresponded, mainly, to Strategic Buyers<sup>1</sup>.
- 83% of the acquisitions were made by investors (domestic or international with a local presence), which we assume aimed to incorporate operational synergies to their ongoing operations in the country.
- Of these, companies controlled by local investors were responsible for 61% of the acquisitions.
- Additionally, of these, companies from Canada, United States, Australia and the Netherlands (directly or through their local subsidiaries) were the most active among international investors.



Similarly, private equity funds focused on the acquisition of companies or business groups that invest through acquisitions are considered as "Financial Investors".

## Breakdown by Country of Origin of Buyer




## Breakdown by Type of Buyer
